
# Introduction

"Way letters are those received by a post rider or contract mail route carrier (an individual or firm performing transportation of the mail by means of stage, wagon, water way vessel, or railroad) on the way between post offices, and which are to be delivered at the first post office reached on the route." (ACCS Vol. II: 152)

The recorded WAY letters in this census are marked with the simple endorsement WAY or with the word in combination with a rate designation. Several Territorial WAY letters do not show the name of the post office where the WAY marking was applied.

This paper is a census of WAY markings in Spanish West Florida and on Florida Territorial and Statehood letters, stagecoach Way-Bill-Box letters, and Railroad Post Office Way markings.

#### Second Spanish Period 1784-1819

During the Second Spanish Period, no postal routes were established in Spanish Florida, mail was handled by nearby United States post offices in Fort Adams, Natchez and Pinckneyville in the Mississippi Territory and New Orleans handled most of the West Florida mail. Mail was picked up from or delivered to persons in Spanish West Florida by couriers / carriers for a 1¢"Way" fee.

\* Red indicates Way letters rates seen in the Florida Census. If  $1\phi$  fee not shown, it was paid to the courier by the postmaster when delivered.

\* Double weight, two letter sheets, paid double the single postage

\*\* The March 3, 1825 Law, Chapter LXIV, Sec. 20 stated: "The post-riders, and other carriers of the mail, receiving any way letter or letters, (and it shall be their duty to receive them, if presented more than one mile from a post-office,) shall deliver the same, together with the postage, if paid, at the first post-office to which they shall afterwards arrive, where the postmaster shall duly enter the same, and specify the number and rate or rates, in the post-bill, adding to the rate of each way letter, one cent, which shall be paid by the postmaster to the mail carrier from whom such way letter shall be received."

A West Florida letter from David Bradford datelined "Bayo Sara July 6, 1802" described the unofficial postal system of Spanish West Florida: "The post is the only conveyance of certainty. Address me at Natchez or Bayou Sara - the postmaster at Natchez knows where I live, and all letters will be forwarded."

Examples of other covers mailed in Spanish West Florida are seen on pages 4-9.

Two 1807 covers datelined "Bayou Sara" and carried by post riders entered the mails in Pinckneyville, Mississippi Territory with a "Way 26" rate reflecting the  $25\phi$  postal rate + 1 $\phi$  "Way" fee. (Page 6 & 7, Type I, Nos. 6 & 7). On page 8 Numbers 11 & 12 show small "p" pinckneyvilleMT "Way" covers.

"NO WAY MARKINGS" (Page 13, Type I, bottom) datelined "Bayou Sara" was personally carried to enter the mails at Fort Adams, Mississippi Territory with a (due) 50¢ rate (red ink indicated postage due).







Way was not lined out since the postmaster paid 1¢ to the captain who delivered the letter from Key West.

The 26¢ was lined out when the letter reached Quincy, because it was included in a pouch of letters going to Washington D.C. Way was not lined out since the postmaster paid 1¢ to the peron who delivered the letter.
