The only Florida Route Agent postmark from the close of the Remele listing in 1861.


The route agent, an employee of the US Post Office Department (USPOD), rode trains with a contract to carry mail between the terminal stations to which he was assigned. Each agent used his handstamp, like a post office's circle date stamp, to mark the loose mail given to him enroute. The marking consisted of the railroad's name, terminal name, or some combination of both, either spelled out full or abbreviated. It was an official USPOD marking.

This listing will comprise principally Florida Route Agents postmarks used in the period from the close of the Remele listing in 1861 to the end of 1886. Also shown are Florida Station Agents postmarks between 1888 – 1899 and Florida Transfer Clerks between 1889 – 1893.

The type of markings with the letters "RR" in the wording were used in general to about 1875 when they were replaced by the "AGENT" markings. On August 1, 1882, an order was issued by the Postmaster General making all routes Railway Post Offices, but many "AGENT" markings continued in use until 1886 or later. By the end of 1886 the "AGENT" markings had mostly been replaced by "R.P.O." handstamps, although a few later usages of "AGENT" marks may be listed.

Items in red indicate a new (20) or updated listing (10).











Florida Station Agents Postmarks

A station agent was employed by the railroad, not the US Post Office Department (USPOD). Occasionally, when a station agent received loose letters, he would place his ticket cancelling device handstamp to mark the letter as if it was a route agent's handstamp. These letters were treated as if they had officially entered the mails. There is evidence station agents were formally sworn in as USPOD representatives when there was no route agent present to take control of the mail.

- Station Agent was also Postmaster of the town. For reasons of economy or for convenience, ticket stamp was used to postmark mail originating at the combined station-post office. This is probably the most common reason, but to establish a solid basis we need to obtain the names of station agents at these small-town stations-a task on which no progress has been made due to lack of source material and detailed local research that is required. This type will be designated as **Postmaster Station Markings**.
- Station Agent, for the convenience of his patrons and fellow townspeople, would receive letters to be mailed and, to save time and trouble, would apply his ticket stamp and hand letters to route agent or R.P.O. clerk on the train. He may have even pouched mail for the train on occasion. Naturally it would be assumed in such cases that the post office was located at some distance from the railroad station. This practice was not officially banned by the Post Office Dept. until Apr. 15, 1882 and the ban seemingly was ineffective. We will label this type of marking as **Convenience Station Markings**.
